Burn Permit Checklist

PLEASE COMPLETE THE QUESTIONS BELOW BY CHECKING THE APPROPRIATE "YES" or "NO" RESPONSE TO DETERMINE WHETHER A BURN PERMIT IS REQUIRED TO BE REVIEWED AND APPROVED BY THE FIRE MARSHAL PRIOR TO BURNING.

A. What type of burning will you be undertaking (Check Only One)?

- CONTAINED BURNING in an incinerator, fireplace or a fireproof container.

OPEN FIRES

Guidelines for Open Burning

- Materials to be burned include only limbs, leaves and natural vegetation;
- No garbage is permitted to be burned;
- No construction debris is permitted to be burned;
- The burn pile cannot exceed six (6) feet in diameter and six (6) feet in height;
- The burn pile must be a minimum of fifty (50) feet from any structure, preferably one hundred (100) feet;
- The burn pile must be at least twenty five (25) feet from any neighboring property lines;
- Do not burn on a windy day;
- The burn pile must be away from other brush, weeds and combustible material;
- The burn pile must be in reach of a garden hose;
- The burn pile must be extinguished at sun down;
- The burn pile must be extinguished if any neighbors complain about smoke;
